Please read the following information about Victorious Festival, the Catering Trader Rules, and the Event Terms & Conditions (collectively, the “Trader T&Cs”). Please note by completing and submitting the online trader application form, you will be deemed to have read and accepted the Trader T&C’s.

VICTORIOUS FESTIVAL OVERVIEW

Victorious Festival is set for its eleventh August Bank Holiday weekend on Southsea Seafront. The festival, located along Southsea’s beautiful seafront, will kick off with a fully open site, Friday 22nd August, Saturday 23rd and Sunday 24th August 2025!

The festival has multiple stages offering a wide variety of music, including two main stages playing host to some of the biggest names in the music industry. 2024 hosted incredible performances from Biffy Clyro, The Pixies, Fat Boy Slim and Snow Patrol to name a few.

Victorious Festival boasts a huge award-winning Kids Arena where all activities and entertainments are free, an array of market and food stalls, comedy acts and free entry to some of the amazing Southsea Seafront attractions within the site. With all of this on offer to ticket holders, the event continues to be one of the best value music festivals in the UK!

The festival also offers festivalgoers the opportunity to camp offsite at Farlington Playing Fields with a camper’s shuttle bus service to and from the festival site. The campsite has also continued to grow – with the capacity steadily increasing and additional campervan pitches getting snapped up.

TRADING AREAS

ALL CATERERS ON THE FESTIVAL SITE ARE **CASHLESS AND ON A REVENUE SHARE PITCH FEE** (with the exemption of Offsite Campsite Traders). Successful applicants are required to pay an upfront deposit to secure a pitch.

COMMON STAGE – **** CASHLESS AND % REVENUE SHARE PITCH. Payment systems will be provided ****

The festival's largest arena where the biggest headline acts will perform. This area also hosts further entertainment and Sponsor activations.

- Opening hours: Fri/Sat/Sun 10:00-23:00

STREET FOOD WAY – **** CASHLESS AND % REVENUE SHARE PITCH. Payment systems will be provided ****

Situated between two of the busiest entrances, Street Food Way is a thoroughfare between the Common Stage and the World Music Village. Due to being situated between popular locations this area experiences high footfall.

- Catering Traders only
- Opening hours: Fri/Sat/Sun 10:00-23:00

FOOD COURT – **** CASHLESS AND % REVENUE SHARE PITCH. Payment systems will be provided ****

This area surrounds Southsea Skate Park with entertainment on its doorstep as well as offering festivalgoers the chance to sit down and chill. The popular Under The Trees Stage is located on one side, as well as being across the road from the Castle Stage. This area hosts a large selection of food with tables/benches provided.

- Opening hours: Fri/Sat/Sun: 10:00-23:00

NEIGHBOURHOOD EATS – **** CASHLESS AND % REVENUE SHARE PITCH. Payment systems will be provided ** Exclusively for Portsmouth City Council local authority registered businesses. LIMITED CAPACITY.**

Honouring our local community! Situated alongside the lively World Music Area, these pitches are exclusively available for local, small/independent food eateries/street food pop-ups and start-ups and will be operating on a discounted % revenue share basis.

- Opening hours: Fri/Sat/Sun 10:00-23:00

CASTLE AVENUE – **** CASHLESS AND % REVENUE SHARE PITCH. Payment systems will be provided ****

Situated outside Henry VIII's historic Southsea Castle, within eyeline of the Castle Stage and leading through to the Seaside Arena, Castle Avenue has festival goer's approaching from all angles! **NB: Marquees CANNOT be staked in as ground in this area unless successful CAT Scan is completed beforehand, ensure you have sufficient weights onsite if required.**

- Catering Traders only
- Opening Hours: Fri/Sat/Sun 10:00-23:00

KIDS AREA – **** CASHLESS AND % REVENUE SHARE PITCH. Payment systems will be provided ****

This area has a great selection of free-of-charge children's entertainment and activities including a dedicated stage, workshops, bouncy castles, arts & crafts, and children's fairground rides! This area caters to families with children, so it closes at 6pm each day.

- Catering Traders & Market Traders
- Opening hours: Fri/Sat/Sun 10:00-18:00

PREMIUM UPGRADE AREA - **** CASHLESS AND % REVENUE SHARE PITCH. Payment systems will be provided ****

This area is situated adjacent to the Common Stage. It has a dedicated site entrance as well as access from the Common Stage. The area includes exclusive bar, toilets, food traders, activities, market traders and access to an undercover viewing platform.

- Opening hours: Fri/Sat/Sun 10:00-23:00

FARLINGTON FIELDS OFF-SITE CAMPING – ****ALL PITCHES ARE FLAT RATE FEE, NOT REVENUE SHARE****

OPEN: THURS/FRI/SAT/SUN/MON

The campsite is located offsite at Farlington Fields (just off the A27/M27) and offers a shuttle bus service running to and from the festival site. Pitches within the campsite have the opportunity of 24hr trading.

- Catering Traders and Market Traders
- Opening Hours: Thurs from 13:00, Fri/Sat/Sun: 24hrs (flexible), Mon until 12:00hrs

REQUIRED DOCUMENTS FROM ALL TRADERS

*Failure to provide these documents will result in you being prohibited to trade. You must provide evidence of your current documentation, even if your document is due to be renewed before or during the event. If your application is accepted and your documents are due to expire within 14 days of the festival, you must provide your updated documents at least 14 days before the festival. **Even if they are not expired when you renew them.***

Insurance

You must maintain the following insurance policies

- a) Public Liability Insurance cover of not less than £5 million for any one claim; and
- b) Product Liability Insurance cover of not less than £5 million for any one claim; and
- c) Employers' Liability Insurance cover of not less than £5 million for any one claim, *if required to do so by law.*

We will ask for a copy of your valid insurance certificate(s). No trade pitch will be fully confirmed without insurance details. Failure to adhere will result in you being prohibited to trade. If your application is successful, **it is your responsibility to provide us with the valid insurance 14 days BEFORE the opening of the event even if it has not expired at the point of renewal.**

Food Hygiene and Safety Certificates / Proof of Food Safety Documentation

All Catering Traders must supply copies of staff Food Hygiene and Safety certs and food safety documentation (this is a document which outlines all the food production you carry out in your business, it highlights all the hazards associated with production, how you control those hazards, how you monitor the control measures you have in place and what to do if things go wrong). A copy must be included within the relevant paperwork required before the event and it must also be available on-site for inspection. If you have more than one unit, you must submit a different cert for each unit's manager.

Local Authority Registration and 'Scores on the Doors' Hygiene Rating

All Catering Traders are required to supply details of their registered local authority, alongside a copy of your 'Scores on The Doors' Star Rating', otherwise the application will not be considered.

Please be aware that **your registration MUST include 'Outdoor Catering' or 'Mobile Catering'**. You will need to speak to your local authority if you are only registered as a food business at a premises in order to gain this extra registration. Your Scores on The Doors rating must be at least 4 stars in order to trade at the Event. Victorious Festivals Ltd and Portsmouth City Council will be checking your local authority.

Fire Risk Assessment

All Traders must supply a completed Fire Risk Assessment; a copy must be included within the relevant paperwork required before the event and it must also be available on-site for inspection. It is your responsibility to ensure fire exits and fire lanes surrounding your stall are kept clear from obstruction throughout the event. Please pay particular attention to the location of your stock, rubbish bags and equipment.

General Risk Assessment

All Traders must supply a completed general Health and Safety Risk Assessment; a copy must be included within the relevant paperwork required before the event and it must also be available on-site for inspection. It is your responsibility to ensure your staff and customers are kept safe, and strict policies are upheld for the highest standards. Please pay particular attention to your refrigeration, hand washing and storage protocols.

Portable Appliance Testing

If your stall requires power then a clear, legible copy of the PAT inspection or electrical systems inspection certificate must be sent to us in your application, otherwise the application will not be considered. More information on PAT testing is available here: **www.pat-testing.info**.

Electrical equipment and appliances must comply with relevant HSE regulations and must have undergone a Portable Appliance Test (PAT) safety check or electrical systems test within the 12 months prior to the festival.

You must ensure that the safety check is carried out by a qualified electrical engineer and that each appliance receives a PAT (portable appliance test) certificate.

When on site, should there be insufficient testing certificates for your electrical equipment, a registered engineer will be called to verify your equipment. You will be liable for costs for any on site testing

Gas Safety Certificate

If your stall uses LPG then a clear, legible copy of the Gas Safe inspection certificate must be sent to us upon application, otherwise the application will not be considered. This certificate must be valid for the event dates, or we will request you to have another completed that is valid for the event.

Gas appliances must comply with relevant HSE regulations and must have undergone a Gas Safe check within the 12 months prior to the festival.

Should there not be sufficient safety checks on your gas equipment, a registered engineer will be called to verify your equipment. You will be liable for the cost on any on-site testing.

IMPORTANT - REVENUE PROTECTION

There will be a proactive revenue protection operation running for the full duration of the Event. All traders operating under the revenue share agreement will be subject to cash test purchasing, have their EPOS devices checked and other revenue protection measures. These operations will be video/recorded, and data stored.

If Traders fail any revenue protection checks, they may be instructed to cease trading and/or may be removed from site. Failing these tests will jeopardise any future trading with Victorious Events and/or other venues. It is traders' responsibility to ensure all staff are aware of these conditions.

ELECTRICITY SUPPLY AND HIRE PRICES

- All electricity will be provided by Victorious Festival's on-site generators. Private generators are NOT permitted.
- Applicants will be required to indicate their anticipated electrical supply requirements at the time of submitting their online application.
- If you require extra power upon arrival this will be charged at a higher rate plus 10%. This will be taken off your revenue share balance. Please note, that any additional electricity supply that is required at the Event is not guaranteed.
- Onsite power inspections will take place. If Traders are found to be using more power than requested and paid for, they will be charged at a higher rate for any additional usage and the total will be deducted from your revenue share balance.

WI-FI SERVICE

- All Catering Traders on revenue share will be provided with payment systems that are pre-connected to Wi-Fi and have the option for offline mode.
- Catering Traders on revenue share are not permitted to use their own Wi-Fi or devices to take payments. This will be deemed as a breach of contract, and Traders may be removed from site.
- Technical services and device trouble shooters will be onsite to resolve any technical and operational issues. Payment terminals provided will have the option for offline mode.
- For Wi-Fi connection outside of your payment terminals. There are no current plans for a pay-for trader Wi-Fi service – if this changes successful applicants will be notified. EE and Vodafone temporary phone masts will be in place for the festival.

CATERING TRADER RULES

Please read the following rules (the “**Catering Trader Rules**”) carefully. By proceeding to the online application and checklist you are confirming you have read, understood, and agree to the terms outlined in the Contractor Pack, including the Catering Trader Rules as detailed below.

Definitions

1. In these Catering Trader Rules, the following definitions and rules of interpretation shall apply:
 - a) references to “*you*”, “*yours*” and “*trader*” shall be construed as references to the individual named on the online application form.
 - b) references to “*Victorious Festival*”, “*we*” and “*us*” shall be construed as references to Victorious Festivals Limited.
 - c) the term “*Market Trader*” refers to anyone who sells items, goods or services that do not involve the preparation or handling of food or drink.
 - d) the term “*Catering Trader*” refers to any trader who sells food or drink.
 - e) references “*Traders*” shall include both Market Traders and Catering Traders; and
 - f) the “*Contractor Pack*” means this document, comprising the following information: (i) Victorious Festival Overview; (ii) the Trading Areas; (iii) Required Documents (iv) Important – Revenue Share (v) Electricity Supply and Hire Prices; (vi) Wi-Fi Service; (vii) the Catering Trader Rules; and (viii) the Event Terms & Conditions.

Application

2. Once you have read this Contractor Pack in full, please complete and submit the online application form.
- 2.1 All successful Traders will receive a confirmation email detailing the next steps in meeting Victorious Festival requirements.

Payment

3. For Traders on Revenue Share, a non-refundable deposit payment is due on acceptance of your application as well as full payment for all additional items (including electricity, green deposit, and any other applicable charges) and must be made by bank transfer to Victorious Festivals Ltd. Your pitch offer is not guaranteed until this payment has been received. You will have a maximum of 14 days (unless the festival falls within this 14 days, in which case your invoice must be paid as per payment terms on your invoice) to pay otherwise the pitch will be offered to another trader.
- 3.1 For Traders on Pitch Fees, full payment is due on acceptance of your application (including electricity, green deposit, and any other applicable charges) and must be made by bank transfer to Victorious Festivals Ltd. Your pitch offer is not guaranteed until this payment has been received. You will have a maximum of 14 days to pay otherwise the pitch will be offered to another trader.
- 3.2 All Traders are required to put up a Green Deposit. Catering Trader Green Deposits are set at **£250 per unit**. Green Deposits will be included on successful applicant invoices. Green Deposits will be returned within 30 days after the event, provided your designated pitch has been left tidy and in good order and relevant account details have been provided. If your pitch is not left tidy and in good order, then Victorious Festivals Ltd have the right to retain all or part of your Green Deposit.
- 3.3 Any disputes will be resolved within 30 days where possible.

Losses

4. By accepting these terms and conditions you acknowledge that neither Victorious Festival nor their designated employees, agents or sub-contractors are responsible or liable for:
 - a) any financial losses incurred by you, any loss of income, or damage to your equipment, goods, stock, or personal belongings.
 - b) any loss of income, or damage to goods caused by adverse weather conditions; or
 - c) any necessary re-siting of stalls, or
 - d) any change of performance program
- 4.1 For the avoidance of doubt, nothing in these terms and conditions shall limit or exclude Victorious Festival's liability for:
 - a) death or personal injury arising from its negligence; or
 - b) fraud or fraudulent misrepresentation
- 4.2 Please note: all Traders are responsible for the safety and security of their own stock, vehicles, and their pitch. It is your responsibility to insure your property against damage.
- 4.3 Victorious Festival does not accept any responsibility for the levels of trade during the event.

Passes

5. There are a limited number of staff and vehicle passes available for your staff and you will be informed of this via email. Details of your staff need to be submitted in advance of the festival date. You will be advised about this simple process in July/August provided your pitch fees/deposit has been paid and appropriate valid documentation confirmed.

On-site

6. Camping on-site is prohibited. The use of caravans, tents or any other overnight accommodation will not be permitted on the event site under any circumstances. Information on the Off-site Campsite will be sent at a later date.
- 6.1 You are responsible for sourcing all furniture, lighting, or other materials and/or equipment you require to display any merchandise.
- 6.2 You acknowledge and accept that you are responsible for the actions and behaviours of your staff while they are on the festival site. We reserve the right to remove any trader staff and/or contractors who we believe are behaving in inappropriate, offensive, or illegal manner, or who have caused damage to any property on the festival site. In such circumstances, your trade stall may be prohibited from trading with Victorious Events in future years.
- 6.3 The Market Management team on behalf of Victorious Festival are solely responsible for the allocation of trade pitch sites and reserve the right to reallocate or re-site a pitch at any time. You are not permitted to move or change your pitch from the location provided by the Market Management team.

Pre-Event Set Up

7. Access to the site may be permitted from **09:00hrs on Wednesday 20th August 2025** and **08:00hrs on Thursday 21st August 2025**. Any trader wishing to access the site earlier than these dates or times can only do so if agreed with the Market Manager prior to the event.

(NB: If setting up **before Thursday** then please be aware that electricity will only be available at an additional cost if required).

- 7.1 All Traders must be set up by **09:00hrs on Friday 22nd August 2025** ready for inspection.
- 7.2 Catering Traders will be inspected by both Portsmouth City Council Environmental Health Officers and Victorious Festival health and safety officers. Please make sure you have all documentation with you for them to look through. Their inspections may take place whilst the event is on.
- 7.3 You are reminded that part of this inspection includes having a sign clearly displayed reminding customers to ask you about food allergens in your food. As well as this you must have a full up-to-date allergen menu and appropriate hand washing facilities.
- 7.4 You may not sub-contract your stall or any part of your stall without our express permission. If you do so, you may be instructed to cease trading and may be prohibited from trading at Victorious Events in future years. No refunds or reimbursements will be given in such circumstances.

On the Day Set-up and Trading Hours:

- 8 All Traders must adhere to the following set-up times and operating hours:
- All Traders** must be set-up for trade by **09:00hrs on Friday 22nd August 2025**.
 - Hours of trading are between **10:00hrs until 23:00hrs on Friday 22nd August 2025, Saturday 23rd August & Sunday 24th August 2025** for everyone unless agreed otherwise.
 - Friday 22nd, Saturday 23rd & Sunday 24th August 2025** all Traders can access the site from **07:00hrs**.

Vehicles, Vehicle Movement and Deliveries

- 9 All Catering Traders are allowed only one stock OR refrigeration vehicle which must remain static on-site behind your stall. You will not be allowed to move your vehicle from this position until vehicle movement is allowed on-site after the festival has ended - estimated time of vehicle movement on-site would be **01:00hrs on Monday 25th August 2025**. **You must not move your vehicle until given express permission by the Market Manager.**
- 9.1 Only re-stock and delivery vehicles with correct vehicle passes will be permitted access to site during set-up hours **07:00-09:00hrs on Friday 22nd, Saturday 23rd, Sunday 24th August**. Details on how to obtain trader vehicle passes and delivery vehicles passes will be issued closer to the event. Victorious Festival does not accept responsibility for receiving deliveries on your behalf. **All vehicles must be offsite by 9am each live event day.**
- 9.2 When driving on-site, you must always adhere to the 5mph speed limit. You must also use turning signals to indicate your direction. Do not use hazards whilst in motion. In the event of adverse weather conditions, we may operate a vehicle movement ban on grassy areas until we deem it is safe to resume vehicular movements. Trader vehicles breaking these rules or failing to adhere to any vehicle movement bans (if applicable) may be asked to cease trading and leave without a refund.

- 9.3 N.B. No trader vehicles whatsoever are permitted to move on-site during live days, i.e. **after 10:00hrs on Friday 22nd, Saturday 23rd, Sunday 24th August. Or before 01:00hrs Monday 25th August.** The only vehicles you will see moving during these times belong to contractors or crew who have been given permission by Victorious Festival Management.
- 9.4 Any Traders needing to leave the site to restock during live hours must transport the supplies on foot. If you expect a delivery item too large to manually handle, notify the Market Manager before your trip and consideration will be given on how the festival may be able help you.
- 9.5 There is no on-site parking, therefore it is the Trader's responsibility to park any vehicles offsite once set up is complete, i.e. by **09:00hrs** excluding one static stock vehicle for Catering Traders only as mentioned in 9.
- 9.6 Trader vehicles will be subject to searches on arrival for load-in and throughout the festival weekend if deemed necessary by our security teams.

Noise and Sound Systems

- 10 Noise must be kept to a minimum at all times. Victorious Festival reserves the right to order trader sound sources to be turned off AT ANY TIME. Unregulated noise pollution could have serious implications on the festival licence. You are not allowed to play music after 22:00hrs during any given day of trading. Sound systems rated over 200 Watts are strictly prohibited.

Products and Tariffs

- 11 You are offered your pitch on the strength of the products and tariffs listed on your application form and accompanying documents. The product list and tariffs should be an accurate representation of what you intend to sell. In some instances, Traders may be asked not to sell certain items to avoid clashes with other Traders.

If Victorious Festival discovers that you are selling products or charging tariffs not listed, we will ask you to withdraw the items or return to the agreed tariff. If you refuse, we reserve the right to enforce closure of your trading operation.

- 11.1 Please be aware that across certain product types, we will be operating a brand exclusivity policy. In these instances, you will be required to ensure that all stock you offer for sale within the relevant product categories are from the designated brand(s). In certain instances, you may also be required to purchase such products from a specified third party. More information on this will be discussed with you upon application.

Animals

- 12 Traders are not allowed to bring animals or pets onto site. You may not keep animals anywhere within the stall's areas. Any animals or pets found with your stall will need to be removed at the owner's expense. Please note these restrictions do not apply to guide dogs which are permitted on site.

Waste, Recycling and Damage

- 13 You are required to keep the area 10 meters in front of your stall tidy and free of rubbish. You must ensure that all waste generated by your stall is placed in the communal bins provided. Please notify us of any unusual requirements. All Catering Traders must supply at least two front of house bins and you must

empty them regularly. You must also ensure you use the correct on-site recycling facilities and that all cardboard is flat packed.

- 13.1 Care should be taken not to cause any damage or change to the site or to any of the fittings, equipment or any other property belonging to the site, to Victorious Festival or any of the contractors. You will be required to pay for any damage, including accidental damage caused. This cost may include transportation and labour costs incurred by such actions.

Fire Safety / Gas / Electricity / Water / Oil

Fire Safety

- 14 Traders are required to have a 5kg dry powder fire extinguisher at their stall, that must have been either inspected by a competent person with BAFE qualifications or equivalent or has been purchased within the last 12 months. Documentation to prove either must be available on-site. Catering Traders must also have a fire blanket. Those with deep fat fryers are also advised to have a wet chemical extinguisher.
- 14.1 All Traders must supply a completed Fire Risk Assessment; a copy must be included within the relevant paperwork required before the event and it must also be available on-site for inspection. It is your responsibility to ensure fire exits and fire lanes surrounding your stall are kept clear from obstruction throughout the event. Please pay particular attention to the location of your stock, rubbish bags and equipment.

Gas

- 15 Other than canisters in use, only one spare cylinder of liquid petroleum gas (LPG) may be kept at your stall at any time, 47kg maximum size. If you wish to store additional LPG cylinders and empty LPG cylinders, please liaise with the Market Manager in advance, or on the day, to ensure use of the event LPG store. Market Management, Hampshire Fire, Health & Safety and Gas Safe technicians WILL inspect to ensure all requirements are met.

Gas appliances must comply with relevant HSE regulations and must have undergone a Gas Safe check within the 12 months prior to the festival. Catering Traders must ensure that the Gas Safe registered engineer inspecting your appliances is qualified to check catering units. We suggest you check on the Gas Safe Register website: www.gassaferegister.co.uk. Once setup, your gas installations will be inspected by a Gas Safe registered engineer.

- 15.1 A clear, legible copy of the Gas Safe inspection certificate must be sent to us on confirmation of your application. No applications will be fully confirmed without relevant Gas Safe certification. Failure to adhere means you will be unable to trade. Should there not be sufficient safety checks on your gas equipment, a registered engineer will be called to verify your equipment. You will be liable for the cost on any on-site testing.

- 15.2 It is a legal requirement for all Catering Traders under the *Gas Safety (Installation and Use) Regulations 1998* that "all commercial catering LPG equipment must have a flame failure device (also called a flame supervision device or thermocouple) so that the gas supply will cut out if the flame is extinguished" Please refer to the NCASS link below for information regarding the legal use of LPG

- 15.3 ***New for 2025*** BRAIDED HOSES MUST NOW BE USED ON ALL LPG CONNECTIONS (copper or steel only). LPG cylinders must be kept a minimum of 1 metre away from your pitch. Please make the necessary adjustments to your application form to adhere to this. This may mean you need a longer hose than in previous years.

Electricity

16 All power to Traders will be provided by on-site generators. No personal generators will be allowed, and any found, may be removed to a place of safety at your expense.

16.1 Electricity requirements need to be detailed on the application form. There will be a charge for power. The prices will be emailed to you once we have confirmation of pricing. Onsite power inspections will take place. If you are found to be using more power than requested and paid for you, will be charged at a higher rate for any additional usage. Payment for this will be due immediately or taken off your revenue share.

You will need to provide your own outdoor, rated Cee-form extension lead to plug into the mains power.

16.2 Electrical equipment and appliances must comply with relevant HSE regulations and must have undergone a Portable Appliance Test (PAT) safety check or electrical systems test within the 12 months prior to the festival. You must ensure that the safety check is carried out by a qualified electrical engineer and that each appliance receives a PAT (portable appliance test) certificate.

A clear, legible copy of the PAT inspection or electrical systems inspection certificate must be sent to us on confirmation of your application. No applications will be fully confirmed without relevant PAT certification. Failure to adhere means you will be unable to trade. More information on PAT testing is available here: www.pat-testing.info.

16.3 When on site, should there be insufficient testing certificates for your electrical equipment, a registered engineer will be called to verify your equipment. You will be liable for costs for any on site testing.

Water

17 The Catering Trader pitch fee includes access to a shared supply of clean water. This will be shared with other Traders. Catering Traders are not permitted to attach a hose for filling water containers from the communal tap. If you wish to have your own personal standpipe, this can be organised for a fee – but you must let us know ASAP.

17.1 Catering Traders must possess appropriate hand washing facilities using hot running water. An urn of hot water and a bowl beneath is not adequate. The hand washing facility must be separate from any sink areas where utensils are washed.

17.2 Wastewater must be disposed of in the grey-water bins (IBCs) as provided by the festival. It must not be poured onto the ground or down a drain. The digging of sumps and soakaways is prohibited.

Oil

18 Under no circumstances is oil to be poured onto the ground, down a drain, or IBC – this will result in forfeiting your Green Deposit. You can however leave your oil in a designated area for it to be collected by an oil recycling scheme. More info to be sent out closer to the event.

18.1 Please note: Victorious Festival takes the health and safety of its patrons and all those working on-site extremely seriously. We reserve the right to remove any Traders and/or trader staff who fail to comply clauses 1.01-8.1 without refund or other compensation.

Structures & Trailers / Deaf & Disabled Accessibility

Structures & Trailers

19 If trading from your own marquee or tent it is your responsibility to ensure the structure is flame retardant.

19.1 All tents, marquees and structures must be securely weighted/staked in and must use guy ropes (if required). Thin straight pegs are prohibited as they are not sufficient, you must use U-pegs or rippled pegs instead. The weather conditions can be windy at the festival site, so ensure you have sufficient ballast on each leg of the marquee.

19.2 Traders must ensure if they are using a pop-up gazebo/structure they are suitably weighed down. Traders that are not staked in must have a minimum of 40kg weight per leg of the structure in the case of high/blustery winds. Garden gazebos are prohibited.

Deaf & Disabled Accessibility

Victorious Festival is committed to being an inclusive event, welcoming Deaf, disabled, and neurodivergent festivalgoers, crew, and performers. To ensure an accessible experience for everyone, we ask all traders to prioritize accessibility at their stalls and venues.

We work closely with Attitude is Everything to assess and improve accessibility standards across the festival, including the markets and bars. Remember, not all disabilities are visible.

Here's a summary of key guidelines to follow:

Step-Free Access

- Ensure your stall provides step-free access wherever possible.
- If your structure has a raised level, include a ramped entrance and exit.

Entrances and Access Routes

- Keep entrances clear, with a minimum width of 1.2m for wheelchair users.
- Avoid placing unnecessary barriers (e.g., A-boards or displays) in access routes.
- Queue systems must be at least 1.2m wide.

Ramps

- Ramps must have a minimum gradient of 1:12, solid handrails, and kickboards along the edges.

- Use non-slip, textured surfaces like roof felt.

Flooring

- Avoid raised flooring where possible. If necessary, ensure ramped access with a minimum width of 1.2m.
- Flooring must be flat, non-slip, and free of trip hazards.

Counters

- Counters should ideally include a lowered section (below 850mm) for wheelchair users, with a recessed area underneath for ease of access.
- If this isn't possible, staff should accommodate by taking orders directly in front of the counter.

Seating Areas

- Ensure routes around seating areas are accessible and leave space for wheelchair users at tables.

Large Print Price Lists

- Provide laminated price lists in easy-to-read formats (Arial, 18pt font, black text on white background).
- Picture-based menus are also encouraged.

Be Friendly and Inclusive

- Train your team to assist all customers with patience and kindness. Patience, kindness and offering extra help will make all the difference to some customers.
- Most disabilities are not visible—be proactive in offering help.
- Display a sign explaining how customers can request additional assistance.

Together, we can ensure Victorious Festival is a welcoming and inclusive experience for all. Thank you for your cooperation!

Prohibited Items

20 Traders are **prohibited** to supply for purchase or gift alcohol in any form whatsoever, for example brandy-coffees.

20.1 Other prohibited items include:

- illegal substances or legal highs or any other psychoactive substances (including NOS canisters and related paraphernalia),
- expletive clothing or accessories and/or clothing advertising illegal substances
- tin foil barbecues or charcoal,
- sky lanterns,
- lasers or laser pens,
- weapons ("fake" and "toys" included), explosives or ammunition of any sort (including fireworks),
- tobacco products,
- vapes or similar items (containing tobacco or not),
- alcohol,
- camping chairs, air loungers or any other portable seating,
- single use plastic,
- glass objects or anything contained in glass; or
- any other articles which may, in our reasonable opinion, cause danger or disruption to visitors at the venue (regardless of whether such item is illegal or is carried for a specific purpose).

Any trader found offering prohibited items will have the items removed. You may be asked to cease trading, or to leave without refund and you may be prohibited from trading at any Victorious Festivals Ltd events in future years. This list is subject to change, we will let you know if anything further has been added.

Health and Safety

21 Traders must comply with work practices outlined within the Health & Safety at Work Act 1974. Catering Traders must comply with legal food safety requirements as found in The General Food Regulations 2004, The Food Hygiene (England) Regulations 2006, and Regulations (EC) 178/2002 and 852/2004. Catering Traders must also comply with legislation on food allergen labelling.

21.1 Catering Traders are required to supply details of the local authority where they are registered with and a copy of your 'Scores on The Doors' Star Rating.

Please be aware that **your registration MUST include 'Outdoor Catering' or 'Mobile Catering'**. You will need to speak to your local authority if you are only registered as a food business at a premises in order to gain this extra registration.

It would help if you submitted your letter or inspection or registration from your local authority. We will be calling these local authorities to verify your status with them. You must have at least 4 stars for hygiene.

No food trade pitch will be fully confirmed without registration details.

Victorious Festival and Portsmouth City Council will be checking with your local authority.

21.2 Catering Traders must comply with the guidance laid out by Portsmouth City Council's Environmental Health Officer and on-site Health & Safety team.

21.3 If you do not regularly trade as a mobile catering unit, you will be given advice on methods to maintain food safety whilst working outdoors as there are many variations to static, indoor catering. Information on this advice meeting will be provided if your application is successful and your pitch is fully confirmed.

21.4 You are required to have a fully stocked first aid box, and you are responsible for supplying first aid for your staff. You are also required to keep an accident book. A festival first aid station and welfare tent will be on-site during event opening hours. Catering Traders must have blue plasters for any minor cuts / injuries.

21.5 Failure to pass inspection by either PCC or Victorious H&S may result in you not being able to trade until the issue/s have been resolved and satisfactory reinspection has taken place.

21.6 Please note: Victorious Festival takes the health and safety of its patrons and all those working on-site extremely seriously. We reserve the right to remove any Traders and/or Trader staff who fail to comply without refund or other compensation.

Non-compliance

22 Victorious Festival and their designated employees reserve the right to remove any trader from the festival site who does not comply with the obligations outlined within this document.

22.1 You will not be permitted to operate your stall if you do not satisfy the licensing requirements of the Local Authority. Neither Victorious Festival, nor its designated employees, can accept any responsibility or liability if this situation occurs.

22.2 You agree to abide by the above clauses of 1.0 – 23.2 and indemnify Victorious Festival and their designated employees against any claim, loss or liability arising from a breach of the above clauses / regulations.

Please read thoroughly

1 INTERPRETATION

1.1 The definitions and rules of interpretation in this clause apply in this agreement:

VF: Victorious Festivals Limited is a company registered in England under number 8775686 whose registered office is at 364-366 Kensington High Street, London, United Kingdom, W14 8NS.

Application Form: the online application form submitted by the Stallholder via the Event website;

Charges: the sums payable for the Space and the attendance at the Event including any sums payable for services supplied by the Stallholder to VF prior to, during or after the Event;

Commercial Rights: any and all rights of a commercial nature connected with the Event whether owned by VF including without limitation, image rights, broadcasting rights, new media rights, endorsement and official supplier rights, sponsorship rights, merchandising rights, licensing rights, advertising rights and hospitality rights;

Event: the event organised or managed by VF which the Stallholder wishes to attend;

Event Equipment: all booths, huts, stalls, tents, buildings,

other constructions, materials, stores, equipment, payment equipment, plant or machinery belonging to, or under the control of, VF that are made available to the Stallholder to be used in connection with the Event;

Event Marks: the logos, marks and trademarks used in promotion, advertising and marketing of the Event, together with any associated artwork, design, slogan, text and other collateral marketing signs of VF that are to be used in connection with the Event Marks;

Event Site: means that part of Southsea Seafront, Portsmouth and such parts where the Event is to take place

Infrastructure means such infrastructure, vehicles and any other equipment whatsoever which Stallholder intends to use in relation to the Event

Force Majeure Event: any event affecting the performance of any provision of this agreement arising from or attributable to acts, events, omissions, or accidents which are beyond the reasonable control of a party including any abnormally inclement weather, flood, lightning, storm, fire, explosion, earthquake, subsidence, structural damage, epidemic or other natural physical disaster, transport, disruptions, failure or shortage of power supplies, war, military operations, riot, crowd disorder, strike, lock-outs or

other industrial action, terrorist action, civil commotion and any legislation, regulations, ruling or omission of any relevant government, court, competent national authority or governing body. However, a force majeure event will not include any shortage of goods, personnel, any increase in prices or reduction in supply or any other circumstances which arise as a result of 'Brexit' (the withdrawal of the United Kingdom from the European Union) howsoever arising;

Holding company, company and subsidiary: the terms "holding company" and "subsidiary" shall be construed as such terms are defined in section 1159 of the Companies Act 2006 and a "company" shall be treated, for the purposes only of the membership requirement contained in subsections 1159(1)(b) and (c), as a member of another company even if its shares in that other company are registered in the name of (a) another person (or its nominee), whether by way of security or in connection with the taking of security, or (b) its nominee;

Relevant Laws: means all relevant statutes, regulations, laws, by laws, trade laws, ordinances, subordinate legislation, common law and binding court orders; all applicable industry codes, policies, guidelines and standards together with all licences (including any premises licence) and all local

authority permissions, licences and authorisations) imposed upon the Trader or otherwise applicable to the exercise of the rights granted hereunder provision and including those relating to hygiene, fire, health and safety, security and all legislation relating to money laundering, anti-bribery and anti-slavery.

Space/Stall: that part of the Event Site allocated to the Stallholder by VF for use during the Event;

Stallholder: the person named on the Application Form;

Stallholder Rules: the rules, regulations and requirements laid down by VF relating to the Event and the use of the Space and attendance at the Event Site by the Stallholder (including, but not limited to the "Contractor Pack", of which these Event Terms and Conditions form part of);

Stand/Stall/Space: the table, booth, chalet, stall, tent, building, or other construction provided by VF or Stallholder for use by the Stallholder during the Event;

Trade Name: the name to be used for the Stallholder set out in the Application Form;

VAT: value added tax chargeable under English law for the time being and any similar additional tax;

1. Clause headings shall not affect the interpretation of this agreement.

1.2 By submitting their application the stallholder understands that they are agreeing to all terms and conditions listed within this document

1.3 The Application Form is part of this agreement.

1.4 A reference to a company shall include any company, corporation or other body corporate, wherever and however incorporated or established.

1.5 A reference to a statute or statutory provision is a reference to it as it is in force for the time being, taking account of any amendment, extension or reenactment and includes any subordinate legislation for the time being in force made under it.

1.6 A reference to writing or written includes e-mail.

1.7 Any obligation in this agreement on a person not to do something includes an obligation not to agree or allow that thing to be done.

2 GRANT OF RIGHTS AND RESERVATIONS

2.1 If the Stallholder's application for a space at the Event is accepted, VF will notify the Stallholder and will grant the Space. The Stallholder will accept the right to take part in the Event, using the Space in accordance with the terms and conditions set out in this agreement.

2.2 VF may grant or refuse any application for a space at the Event and allocate such spaces in its absolute discretion. VF may cancel any Space or part of any Space at any time, including during the Event, where the Stallholder is in breach of the terms of this agreement in any way.

2.3 Subject to the Stallholder having paid all sums due to VF in full, and subject to availability, VF will allocate a

Space to the Stallholder. If the Stallholder's application is rejected, VF shall refund any monies paid to VF in full. VF reserves the right in its absolute discretion to alter the Space allocated at any time up to the commencement of the Event and during the Event.

2.4 The Stallholder acknowledges that VF reserves the right to expel any person from the Event Site where VF in its absolute discretion believes that their conduct or presence may be prejudicial to the operation of the Event, or the enjoyment of the Event by other Stallholders or visitors.

3 CANCELLATIONS BY STALLHOLDER

3.1 The Stallholder may cancel the application for a Space at any time prior to the Event. If the Stallholder cancels its reservation of the Space more than 45 days prior to the Event, VF shall refund any Charges paid by the Stallholder, subject to the deduction of (i) any costs incurred by VF (including in relation to third parties); (ii) any non-refundable deposit and (iii) an allowance for administrative costs. If the Stallholder cancels its reservation within 30 days of the Event, the Charges paid by the Stallholder to VF will not be refunded and VF shall be entitled to retain all such sums.

For the purpose of this clause the day that notice is given and the day of the Event shall be excluded when calculating the number of days.

4 OBLIGATIONS OF THE STALLHOLDER

4.1 The Stallholder warrants and represents to VF:

4.1.1 that the information supplied on the Application Form is true and accurate;

4.1.2 that all persons working at the Space are lawfully entitled to work for the Stallholder in England and, where the person is not a UK citizen, have all visas, permits or other authorisations required.

4.2 Upon successful application the Stallholder agrees to pay the Charges on or before the date specified by VF.

4.3 The Stallholder undertakes to VF:

4.3.1 To comply with the Stallholder Rules

4.3.2 to ensure that all stock, equipment, goods, chattels or material of any sort belonging to, or being used by, the Stallholder is kept within the Space at all times unless otherwise agreed by VF (and any such permission given may be revoked at any time);

4.3.3 To use the Space strictly in accordance with the terms of this agreement and that it will be responsible for any damage caused by the Stallholder or its employees, agents or contractors to the Space, the Event Site or VF's Equipment. The Stallholder agrees that it shall pay to VF immediately upon request any and all costs (without deduction or set off) incurred by VF in relation to the rectification any such damage;

4.3.4 To co-operate with and obey instructions or directions given by event staff, security dogs and security staff, in pursuance of their duties at the Event Site and to consent to such persons searching any

vehicles, containers, equipment, workbags and other chattels owned by the Stallholder, its employees, agents or sub-Contractors whilst the chattels are on, or as a condition of access to, the Event Site.

4.3.5 To use the Event Marks and other branding materials provided by VF in accordance with any guidelines issued by VF;

4.3.6 To apply any legal notices as required by VF or as set out in the Stallholder Rules;

4.3.7 To ensure that all materials and products stocked, stored, used, promoted, published, distributed or sold by the Stallholder shall be safe and fit for their intended use and shall comply with all Relevant Laws, Stallholder Rules, and best industry practice;

4.3.8 Not to apply for registration of any part of the Event Marks or anything confusingly similar to the Event Marks as a trademark for any goods or services;

4.3.9 Not to use the Event Marks or any part of them or anything confusingly similar to them in its trading or corporate name or otherwise, except as authorised under this agreement;

4.3.10 Not to use or exploit any of the Commercial Rights of the Event in any way or do or permit anything to be done which might adversely affect any of the Commercial Rights of VF or the value of the Commercial Rights;

4.3.11 Not to act in a way that is offensive, obscene or derogatory in nature or defamatory of any third party;

4.3.12 to provide such advice and assistance as VF may reasonably request;

4.3.13 provide such documents to VF on demand as VF may request, including risk assessments, method statement and any other health and safety document and licenses and certificates of insurance;

4.4.14 install, operate and remove any infrastructure and equipment (as all approved by VF) at such part of the Event site as notified by VF at such times as stated by VF;

4.4.15 not alter or re-site the appearances and/or layout of the infrastructure and equipment once it has been finalized and approved by VF;

4.4.16 keep and maintain all infrastructure and equipment in a clean, orderly and sanitary condition and in good repair at all times during the Event;

4.4.17 ensure that the Space is fully operational on each day of the Event and during all inspections

4.4.18 ensure that the Stall does not contain any advertising or branding of any nature without VF's prior approval and not use any branding, advertising or marketing materials at or in relation to the Event without the prior approval of VF.

4.4.19 The Stallholder has no right to sub-license, assign, sub-contract or otherwise share the rights granted under clause 2.1, without VF's prior written consent.

4.5 The Stallholder acknowledges that VF has the

rights to the Event and the Event Marks subject to the rights of Portsmouth City Council and agrees that the Stallholder has no right, title or interest in them except to the extent permitted by this agreement.

4.6 The Stallholder warrants and undertakes that it has and shall at all times retain the right to enter into the Agreement and perform its obligations hereunder in accordance with all reasonable care and skill, with best industry practice, with all Relevant Laws and within the highest standards of safety.

5 ANTI-BRIBERY

5.1 The Stallholder agrees that it shall comply with all applicable laws, statutes, regulations and codes relating to anti-bribery and anticorruption including but not limited to the Bribery Act 2010 (Relevant Requirements) and maintain in place throughout the term of this agreement its own policies and procedures, including but not limited to adequate procedures under the Bribery Act 2010, to ensure compliance.

6 LIMITATION OF LIABILITY AND INDEMNITIES

6.1 The Stallholder undertakes to indemnify VF against all liabilities, claims, demands, actions, costs, damages or loss arising out of (i) any breach of any of the terms of this agreement by the Stallholder; (ii) any act or omission of the Stallholder.

6.2 The Stallholder shall further indemnify and keep indemnified VF from and against all claims, damages, losses, costs (including all

reasonable legal costs), expenses, demands or liabilities resulting from any claim by any third party (including, without limitation, any governmental authority), resulting from or arising out of or in any way connected to the products sold or supplied by the Stall holder.

6.3 Nothing in this agreement shall exclude or restrict either party's liability for death or personal injury resulting from the negligence of that party or its employees while acting in the course of their employment.

6.4 Subject to clause 6.3, under no circumstances shall VF be liable to the Stallholder for any of the following, whether in contract, tort (including negligence) or otherwise:

6.4.1 any indirect or consequential losses;

6.4.2 loss of revenue or anticipated revenue;

6.4.3 loss of savings or anticipated savings;

6.4.4 loss of business opportunity;

6.4.5 loss of profits or anticipated profits; or

6.4.6 loss of wasted expenditure inc. stock.

6.5 VF's maximum aggregate liability in contract, tort (including negligence) or otherwise, however arising, out of or in connection with the performance of VF's obligations under this agreement shall be limited to a sum equal to the Charges paid to VF by the Stallholder.

7 TERMINATION

7.1 Without prejudice to any rights that have accrued under this agreement or any of its rights or remedies, VF may terminate this agreement with immediate effect at any time by giving verbal and written notice to the Stallholder if:

7.1.1 The Stallholder fails to pay any amount due under this agreement on the due date for payment and remains in default after being notified in writing to make payment;

7.1.2 The Stallholder commits a material breach of any term of this agreement (other than failure to pay any amounts due under this agreement) and (if that breach is remediable) fails to remedy that breach within the period specified by VF after being notified in writing to do so;

7.1.3 The Stallholder repeatedly breaches any of the terms of this agreement in a manner that reasonably justifies the opinion that its conduct is inconsistent with it having the intention or ability to give effect to the terms of this agreement;

7.1.4 VF's right to hold the Event is terminated by Portsmouth City Council.

7.2 Either party may terminate this agreement with immediate effect at any time by giving written notice to the other party if:

7.2.1 The other party suspends, or threatens to suspend, payment of its debts or is unable to pay its debts as they fall due or admits inability to pay its debts or (being a company or limited liability partnership) is deemed unable to pay its debts within the meaning of section 123 of the Insolvency Act 1986 or (being

an individual) is deemed either unable to pay its debts or as having no reasonable prospect of so doing, in either case, within the meaning of section 268 of the Insolvency Act 1986 or (being a partnership or limited liability partnership) has any partner or member to whom any of the foregoing apply;

7.2.2 A petition is filed, a notice is given, a resolution is passed, or an order is made, for or in connection with the winding up of that other party (being a company or limited liability partnership) other than for the sole purpose of a scheme for a solvent amalgamation of that other party with one or more other companies or the solvent reconstruction of that other party.

7.2.3 An application is made to court, or an order is made, for the appointment of an administrator, or if a notice of intention to appoint an administrator is given or if an administrator is appointed, over the other party (being a company or limited liability partnership);

7.2.4 The holder of a qualifying floating charge over the assets of that other party (being a company or limited liability partnership) has become entitled to appoint or has appointed an administrative receiver;

7.2.5 A person becomes entitled to appoint a receiver over the assets of the other party or a receiver is appointed over the assets of the other party;

7.2.6 A creditor or encumbrancer of the other party attaches or takes possession of, or a distress,

execution, sequestration or other similar process is levied or enforced or sued against, the whole or any part of the other party's assets and that attachment or process is not discharged within ten days;

7.2.7 The other party (being an individual) is the subject of a bankruptcy petition or order;

7.2.8 Any event occurs, or proceeding is taken, with respect to the other party in any jurisdiction to which it is subject that has an effect equivalent or similar to any of the events mentioned in clauses 7.2.6 - clause 7.2.7(inclusive);

7.2.9 The other party suspends or ceases, or threatens to suspend or cease, to carry on all or a substantial part of its business;

7.2.10 The other party (being an individual), dies or, by reason of illness or incapacity (whether mental or physical), is incapable of managing his own affairs or becomes a patient under any mental health legislation.

8 CONSEQUENCES OF TERMINATION

8.1 Following termination of this agreement for whatever reason:

8.1.1 The Stallholder shall immediately vacate the Space and remove all items belonging to the Stallholder causing as little disturbance as possible to the Event, VF, other Stallholders or attendees;

8.1.2 Each party shall promptly return to the other any property (including any and all of VF's Equipment) of the other within its possession or control;

8.1.3 Each party shall pay to the other any sums that are outstanding and to be accounted for under this agreement;

8.1.4 Clauses which expressly or by implication have effect after termination shall continue in full force and effect.

9 FORCE MAJEURE AND EVENT CANCELLATION

9.1 Any party that is subject to a Force Majeure Event shall not be in breach of this agreement and shall be excused from performance under this agreement while and to the extent they are unable to perform due to any Force Majeure Event, provided that:

9.1.1 It promptly notifies the other party in writing of the nature and extent of the Force Majeure Event causing its failure or delay in performance;

9.1.2 It could not have avoided the effect of the Force Majeure Event by taking precautions which, having regard to all the matters known to it before the Force Majeure Event, it ought reasonably to have taken, but did not; and

9.1.3 it has used all reasonable endeavors to mitigate the effect of the Force Majeure Event, to carry out its obligations under this agreement in any way that is reasonably practicable and to resume the performance of its obligations as soon as reasonably possible.

9.2 If the circumstance of a Force Majeure Event continues after the Event, the party not affected by the Force Majeure Event shall have the right to

terminate this agreement upon written notice to the other. This termination shall be without prejudice to the rights of the parties in respect of any breach of this agreement occurring before termination.

9.3 If the Event is cancelled or abandoned for any reason (including, without limitation, by reason of a Force Majeure Event or under circumstances referred to in clause 9.1.3) VF shall notify the Stallholder of the cancellation as soon as possible. The parties agree that:

9.3.1 VF shall not be in breach of this agreement by virtue of that cancellation or abandonment;

9.3.2 (Without prejudice to their rights and liabilities arising before this cancellation) the parties shall, in respect of the period following VF's notice, thereafter, be relieved of their rights and obligations under this agreement in respect of the event.

10 VALUE ADDED TAX

10.1 All sums payable under this agreement are exclusive of any VAT that may be payable, and VAT will be added to the invoice.

11 USE OF DATA

11.1 The Stallholder agrees to VF holding information on the Stallholder for the purposes of the Event, and to notify the Stallholder of future events.

11.1.1 The stallholder agrees to VF to use and store their information submitted upon application for future statistic and measurement of data.

11.2 The Stallholder agrees to VF releasing the name and business address of the Stallholder to any person complaining about any service or products supplied by a Stallholder.

11.3 The stallholder agrees to allow VF to use their information to provide advertisement over VF's social media, including but not limiting to, their trading name, bio, social media, and website.

12 LATE PAYMENT INTEREST

12.1 If the Stallholder does not pay any amount payable under this agreement by its due date, the Stallholder shall pay to interest on the outstanding amount at a rate of 5% a year above the Bank of England base rate from time to time from the due date for payment until the date on which VF receives the outstanding amount. The payment of the interest will be in addition to, and not in substitution for, any other remedies available in respect of the non-payment.

13 GENERAL

13.1 Nothing in this agreement is intended to, or shall be deemed to, establish any partnership or joint venture between any of the parties, constitute any party the agent of another party, nor authorise any party to make or enter into any commitments for or on behalf of any other party.

13.2 Save as set out in clause, this Agreement is not intended to, and does not give any person who is not a party to it any right to enforce any of its provisions under the Contracts (Rights of Third Parties) Act 1999. VF shall be entitled to enforce those provisions of this Agreement intended to

benefit VF.

13.3 No variation of this agreement shall be effective unless it is in writing and signed by each of the parties (or their authorised representatives).

13.4 No failure or delay by a party to exercise any right or remedy provided under this agreement or by law shall constitute a waiver of that or any other right or remedy, nor shall it preclude or restrict the further exercise of that or any other right or remedy. No single or partial exercise of a right or remedy shall preclude or restrict the further exercise of that or any other right or remedy.

13.5 If any court or competent authority finds that any provision of this agreement (or part of any provision) is invalid, illegal, or unenforceable, that provision or part-provision shall, to the extent required, be deemed to be deleted, and the validity and enforceability of the other provisions of this agreement shall not be affected.

13.6 If any invalid, unenforceable or illegal provision of this agreement would be valid, enforceable, and legal if some part of it were deleted, the provision shall apply with the minimum modification necessary to make it legal, valid, and enforceable.

13.7 This agreement constitutes the entire agreement between the parties and supersedes and extinguishes all previous drafts, agreements, arrangements and understandings to date between them, whether written or oral, relating to its

subject matter.

13.8 Each party agrees that it shall have no remedies in respect of any representation or warranty (whether made innocently or negligently) that is not set out in this agreement.

13.9 A party (receiving party) shall keep in strict confidence all technical or commercial know-how, specifications, inventions, processes, or initiatives which are disclosed to the receiving party by the other party (disclosing party), its employees, agents or subcontractors, and all other confidential information concerning directly or indirectly the disclosing party's business, its products or its services which the receiving party may obtain, including the terms of this Contract. The receiving party shall only disclose such confidential information to those of its employees, agents or subcontractors who need to know the same for the purpose of discharging the receiving party's obligations under the Agreement, and shall ensure that such employees, agents, or subcontractors shall keep such information confidential.

14 NOTICES

14.1 Any notice or other communication required to be given to a party under or in connection with this contract shall be in writing.

14.2 This clause does not apply to the service of any proceedings or other documents in any legal action or, where applicable, any arbitration or other method of dispute resolution. For the purposes of this clause, "writing" shall include e-mail.

15 GOVERNING LAW AND JURISDICTION

15.1 This agreement and any dispute or claim arising out of or in connection with it or its subject matter (including non-contractual disputes or claims) shall be governed by and construed in accordance with the law of England and Wales.

15.2 The parties irrevocably agree that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute or claim that arises out of or in connection with this agreement or its subject matter or formation (including non-contractual disputes or claims).

16 DISCLAIMER
